# MILITARY AUTOSOURCE INC. OFFICIAL RULES AND REGULATIONS 2025 Volkswagen Jetta MAS 65<sup>th</sup> Anniversary Giveaway

# No purchase necessary to enter or win the 2025 Volkswagen Jetta MAS 65<sup>th</sup> Anniversary Giveaway (the "<u>Giveaway</u>"). A purchase does not improve your chances of winning.

1. ELIGIBILITY: The Giveaway is open to U.S. Military Personnel and Attached Civilians, 18 years or older with a valid driver's license, who are authorized by the Exchange/NEXCOM to purchase through the military exchange system and who are stationed, deployed or on TDY (for at least 30 days) OCONUS in Europe during the Giveaway Period (as defined in Section 2).

Each entry must be filled out completely and accurately with the entrant's (1) first and last name, (2) daytime telephone number (including area code/country code), and (3) email address. Online entrants must have a valid email address and phone number in order to enter. Any form of entry other than that described in this Section 3 is void. MAS reserves the right to cancel or modify the Giveaway if fraud destroys the integrity of the promotion as determined by MAS in its sole discretion. ## 6. DRAWINGS AND ODDS OF WINNING:

**Location Finalists:** Each of the nine (9) MAS off base locations in Europe (Aviano, Grafenwöhr, Kaiserslautern, Lakenheath, Lens, Ramstein, Spangdahlem, Stuttgart and Wiesbaden) will hold four (4) drawings during the giveaway period on the dates designated below to determine the 36 location finalists. Each drawing will be chosen at random and will include all entries taken at that location as of the date of the draw. The odds of being selected as a finalist will be determined by the number of eligible entries received by MAS at the time of each draw.

**Online Entry Finalist:** One (1) semifinalist will be selected from all online entries. The finalist will be contacted via e-mail or phone by MAS within seven (7) days of the drawing and must show proof of eligibility. #### **Grand Finale Participants**

Ten (10) semifinalists will be selected from above to attend the live Grand Finale Event on Saturday, 18 October 2025 at the MAS Kaiserslautern off base location in Germany. This includes (9) location semifinalists, and one (1) semifinalist from all online entries as outlined in Section 6. Attendance is mandatory at the event for all finalists in order to win. If a finalist cannot attend due to deployment, PCS, or other valid reasons, they may nominate a representative to attend on their behalf. This must be arranged and approved by MAS in writing prior to the event.

On the day of the grand finale event, all event attendees, [including those who may have previously entered the preceding giveaways but were not selected,] will have the opportunity to enter a drawing, [no purchase necessary,] upon arrival to be named as semifinalist number eleven (11). This semifinalist will be randomly selected from the entries collected at the event on 18 October 2025 and must remain present at the event to be eligible to win.
