

MILITARY AUTOSOURCE INC. OFFICIAL RULES AND REGULATIONS 2026 Celebrating America Sweepstakes

No purchase necessary to enter or win the 2026 Celebrating America Sweepstakes (the “Sweepstakes”). A purchase does not improve your chances of winning.

1. **ELIGIBILITY:** The Sweepstakes is open to U.S. Military Personnel and Attached Civilians, 18 years or older with a valid driver’s license, who are authorized by the Exchange/NEXCOM to purchase through the military exchange system and who are stationed, deployed or on TDY (for at least 30 days) OCONUS during the Sweepstakes Period (as defined in Section 2).

Employees and families of Military AutoSource Inc. (“MAS”) and its affiliates, the Exchange/NEXCOM, Ships Stores and its affiliates and subsidiaries are not eligible to enter. Void where prohibited by law. All federal, state and local laws and regulations apply.

2. **PROMOTION PERIOD:** Saturday, 21 February 2026 at 0001 hours at 0001 hours/Chamorro Standard Time (ChST) and ends Wednesday, 30 September 2026 at 2359 hours/Eastern Time (ET) (the “Sweepstakes Period”). All entries must be received by and recorded by MAS during the Sweepstakes Period to be eligible for the drawing.
3. **HOW TO ENTER:** Limit of one entry per person. Each entrant must complete and submit in full an official entry form at militaryautosource.com/America from a computer or mobile device, or with an MAS Sales Representative at any OCONUS on base MAS location. Each entry must be filled out completely and accurately with the entrant’s (1) first and last name, (2) daytime telephone number (including area code/country code), and (3) email address. Online entrants must have a valid email address and phone number in order to enter. **Any form of entry other than that described in this Section 3 is void.** MAS reserves the right to cancel or modify the Sweepstakes if fraud destroys the integrity of the promotion as determined by MAS in its sole discretion. All entries become the property of MAS and will not be returned or acknowledged.
4. **WINNER’S PERSONAL INFORMATION:** If you are selected as the Winner (as defined in Section 7), your name may be included in a publicly available winner’s list (“Winner’s List”). The inclusion of your name in a Winner’s List is subject to (1) your consent, (2) the MAS Privacy Policy set forth in Section 5, and (3) the conditions set forth in Section 9.
5. **PRIVACY:** The collection, use, and sharing of personal information provided in conjunction with the Sweepstakes will be governed by the MAS Privacy Policy, located at <https://militaryautosource.com/privacy> or militaryautosource.com/America.
6. **GRAND PRIZE:** One (1) winner will receive a cash prize of Thirteen Thousand Dollars (USD \$13,000), representing the equivalent of Two Hundred Fifty Dollars (USD \$250) per week for fifty-two (52) weeks (the “Cash Prize”), payable in a single lump-sum payment. No portion of the prize shall be payable in multiple payments or installments. All other costs not specifically stated herein as being awarded are the responsibility of the Winner. Taxes (INCLUDING ANY INCOME AND WITHHOLDING TAXES) are the sole responsibility of the winner, regardless of whether prize is used in whole or in part. Winner will be issued an appropriate IRS Form 1099 for the retail value of the prize. No substitution or transfer of a prize will be permitted. In the event that a potential winner is disqualified for any reason, Military AutoSource reserves the right to award the prize to an alternate winner, even if the disqualified potential winner’s name may have been publicly announced. 7. **WINNER DRAWING AND ODDS OF WINNING:** One (1) winner will be chosen from all eligible entries at random at the end of the Sweepstakes period, Thursday 1 October 2026, to receive the Cash Prize, (the “Winner”) in accordance with Section 6. The Winner will be selected at random by MAS. The odds of winning will be determined by the number of eligible entries received by MAS during the Sweepstakes Periods. The drawing will be held at the MAS office in Woodbury, NY. The Winner will be contacted via e-mail or phone by

MAS within seven (7) days of the drawing and must show proof of eligibility. In the event MAS cannot locate the Winner within ten (10) days of the date of attempted notification, the individual's status may be forfeited, and an alternate winner chosen. MAS is not responsible for any change of e-mail address or phone number of entrant.

8. **NO SUBSTITUTION:** No substitution or transfer of a prize will be permitted. In the event that a potential winner is disqualified for any reason, MAS reserves the right to award the prize to an alternate winner, even if the disqualified potential winner's name may have been publicly announced.

NO TRAVEL OR OTHER ACCOMODATIONS: ALL TRAVEL, LODGING, TRANSPORTATION AND ANY OTHER ACCOMMODATIONS ASSOCIATED WITH ANY OF THE WINNER'S ACCEPTANCE OF THE PRIZES ARE THE SOLE RESPONSIBILITY OF THE WINNER. THE PRIZES INCLUDE ONLY THE ITEMS LISTED IN SECTION 6, AND MAS WILL NOT COVER ANY ADDITIONAL EXPENSES INCURRED BY ANY OF THE WINNER.

DISQUALIFICATION:** Persons who tamper with or abuse any aspect of the Sweepstakes or website, who are in violation of these Official Rules, or who act in an unsportsmanlike or disruptive manner as solely determined by MAS, will be disqualified and all associated entries will be void. Automated entries are prohibited, and any use of automated devices will cause disqualification. MAS reserves the right at its sole discretion to disqualify any individual who tampers with the entry process. Entrants may not register with multiple email addresses, nor may entrants use any other device or artifice to register multiple times or as multiple registrants. Any entrant who attempts to enter with multiple email addresses under multiple identities or uses any device or artifice to enter multiple times will be disqualified and forfeits any and all prizes won, in MAS's discretion.

RIGHT TO CANCEL OR MODIFY:** MAS reserves the right at its sole discretion to suspend, modify or terminate the Sweepstakes for any reason, including, but not limited to, should any portion of the Sweepstakes be, in MAS's sole opinion, compromised by virus, worms, bugs, non-authorized human intervention or other causes which, in the sole opinion of the MAS, corrupt or impair the administration, security, fairness or proper play, or submission of entries, and, if terminated, at its discretion, randomly select the winner from among all eligible, non-suspect entries received prior to action taken or as otherwise deemed fair and appropriate by MAS.

LIMITATION OF LIABILITY:** By entering the Sweepstakes, entrants agree that MAS shall not be responsible or liable for, and are hereby released from, any and all costs, injuries, losses or damages of any kind, including, without limitation, death and bodily injury, due in whole or in part, directly or indirectly, to participation in the Sweepstakes or any Sweepstakes related activity, or from entrant's acceptance, receipt, possession and/or use or misuse of a prize.
