

MILITARY AUTOSOURCE INC. OFFICIAL RULES AND REGULATIONS 2026 Europe Exchange Gift Card Giveaway

No purchase necessary to enter the Europe Exchange Gift Card Giveaway (the “Giveaway”). A purchase does not improve your chances of winning.

1. **ELIGIBILITY:** The Giveaway is open to U.S. Military Personnel and Attached Civilians, 18 years or older with a valid driver’s license, who are authorized by the Exchange/NEXCOM to purchase through the military exchange system and who are stationed or deployed OCONUS in Europe during the Giveaway Period (as defined in Section 2).

Employees and families of Military AutoSource Inc. (“MAS”) and its affiliates, the Exchange/NEXCOM, Ships Stores and its affiliates and subsidiaries are not eligible to enter. Void where prohibited by law. All federal, state and local laws and regulations apply.

2. **GIVEAWAY PERIOD:** The Giveaway begins Thursday, 1 January 2026 at 0001 hours/Central European Time (CET) and ends Thursday, 31 December 2026 at 2359 hours/Central European Time (CET) (the “Giveaway Period”). All entries must be received by and recorded by MAS during the Giveaway Period to be eligible for the drawing. One (1) individual will be chosen on the final day of each of the following periods: (i) January 1, 2026 to February 28, 2206, (ii) March 1, 2026 to April, 30, 2026, (iii) May 1, 2026 to June 30, 2026, (iv) July 1, 2026 to August 31, 2026, (v) September 1, 2026 to October 31, 2026, (vi) November 1, 2026 to December 31, 2026 (collectively, the periods shall be referred to as the “Giveaway Periods” and each, a “Giveaway Period”).
3. **HOW TO ENTER:** Limit of one entry per person. Each entrant must complete and submit in full an official entry form at <https://militarycarprogram.militaryautosource.com/Exchange-Giveaway.html> from a computer or mobile device, or to a MAS Sales Representative at any on base MAS location in Europe. Each entry must be filled out completely and accurately with the entrant’s (1) first and last name, (2) daytime telephone number (including area code/country code), and (3) email address. Online entrants must have a valid email address and phone number in order to enter. **Any form of entry other than that described in this Section 3 is void.** MAS reserves the right to cancel or modify the Giveaway if fraud destroys the integrity of the promotion as determined by MAS in its sole discretion. All entries become the property of MAS and will not be returned or acknowledged.
4. **WINNER’S PERSONAL INFORMATION:** If you are selected as the Winner (as defined in [Section 7](#)), your name may be included in a publicly available winner’s list (“Winner’s List”). The inclusion of your name in a Winner’s List is subject to (1) your consent, (2) the MAS Privacy Policy set forth in [Section 5](#), and (3) the conditions set forth in [Section 9](#).

6. **GRAND PRIZE:** Six (6) prize winners (the “Winner”), selected bimonthly, in Europe will receive a \$250 Exchange Gift Card (the “Prizes” and each, a “Prize”).
7. **WINNER DRAWING AND ODDS OF WINNING:** The individuals chosen pursuant to Section 2, (the “Winners” and each, a “Winner”) will receive a \$250 Exchange Gift Card. If a Winner is located in a Navy location, they can receive a NEXCOM Gift Card. The Winner will be selected at random by MAS. The odds of winning will be determined by the number of eligible entries received by MAS during the Giveaway Period. The drawing will be held at the MAS office in Woodbury, NY. The Winner will be contacted via e-mail or phone by MAS within seven (7) days of the drawing and must show proof of eligibility. In the event MAS cannot locate the Winner within thirty (30) days of the date of attempted notification, the individual’s status

may be forfeited, and an alternate winner chosen. MAS is not responsible for any change of e-mail address or phone number of entrant.

8. **NO SUBSTITUTION:** No substitution or transfer of a prize will be permitted. In the event that a potential winner is disqualified for any reason, MAS reserves the right to award the prize to an alternate winner, even if the disqualified potential winner's name may have been publicly announced.
